Historical Context – The mark of the cross

The tradition of marking the forehead with ash on Ash Wednesday can be traced back to the ancient Jewish action of dusting oneself with ash as a sign of repentance and mourning for wrongful actions. It was a public declaration of the acknowledgement of the wrong and the commitment to turn one's life around and try not to make the same mistake again. It still remains a public declaration that during the period of Lent those who wear the cross of ash are going to attempt to turn around their lives and re-focus themselves more fully on God.





Every day, millions of people walk long distances to school, to gather food or to retrieve water. Throughout Lent we are asking our community to donate money towards Project Compassion. COVID UPDATE:

St Mary's has recently received updated guidelines relating to COVID-19. Please take note of the following and speak with Mrs Carter if you have any questions.

- Free rapid antigen tests will be made available for all students in Victorian schools throughout Term 1 2022. You will have received your most recent supply of RAT kits last week.
- Students who report a positive result must isolate themselves for seven days and not attend school during that period.
- Where a student is a household contact of a positive case (that is, they have spent more than four hours with someone who has COVID-19 inside a house, accommodation, or care facility) they must inform the school and isolate for seven days and not attend school during that period.
- Students must refrain from returning to school if they remain symptomatic, unless it is known that their symptoms are caused by an underlying health condition or medication.
- If during the quarantine period an additional member of the household has returned a positive result, household contacts are NOT subjected to rolling quarantine periods. The quarantine end date for the close contact is unchanged and the student can safely return to school. *Please note, if the student becomes symptomatic. They should get tested and not attend school.*
- All students are expected to attend onsite unless they are formally registered as being home-schooled. Parent preference is not an approved reason for students to be absent due to COVID-19.
- Vaccination is not mandatory for students; however, in alignment with health advice, vaccinations are

strongly encouraged as the best way to protect individuals, families and school communities from further outbreaks and the spread of COVID-19.

- In Victorian Catholic schools, parents, carers and other adult visitors who enter school buildings must be able to show evidence of two doses of COVID-19 vaccine or have a valid medical exemption.
- Staff, Visitors and Students in Grade 3 to Grade 6 must wear a face mask indoors and when on public transport, unless a lawful exemption applies. Students in Prep to Grade 2 are strongly recommended to wear a face mask indoors at school.
- The Service Victoria QR code check-in is no longer required at schools. Routine school visitor record keeping arrangements will continue to apply such as signing in at the Office.
- We continue to employ a range of COVID Safe practices to help keep our school community safe. These include ventilation and air purification, hand sanitising and physical distancing.
- All students have a Home Learning Matrix in their reader bags for any time they may be required to isolate due to COVID-19. If you have any questions regarding the work packs, please contact the classroom teachers.

In order to prepare for the language & learning demands of the school environment, children need ample time and opportunity to engage in meaningful interactions with their family.


Receptive Language (Language Comprehension)

Collection Notice for parents/guardians

2022 Student Residential Address and Other Information

The Australian Government Department of Education, Skills and Employment (the department) would like to notify you that a request has been made for your child's school to provide residential address and other information as required under the Australian Education Regulation 2013.

The school is required to provide the department with the following information about each student at the school:

- Names and residential addresses of student's parent(s) and/or guardian(s)
- Student residential address (excluding student names)
- Whether the student is a primary or secondary student (education level)
- Whether the student is boarding or a day student (boarding status).

The school collects the above information by generating a **unique and unidentifiable** – student reference number (SRN) for each student record. The SRN is also **only** used by the school for this collection. It is not **allowed to be used for any other purpose**. The number only indicates to the department that each record provided is for one student.

Purpose of the collection

The Student Residential Address and Other Information Collection (the Collection) informs Australian Government school education policy and helps ensure funding for non-government schools is based on need basis.

The information collected will be used to inform school funding calculations. It is combined with data held by the Australian Bureau of Statistics (ABS) to calculate a non-government school community's anticipated capacity to contribute to the costs of schooling.

From 2020, a new measure of capacity to contribute, the Direct Measure of Income (DMI), was introduced. The DMI is based on the median income of parents or guardians of students at a non-government school using data collected through the Collection. More information about the DMI can be found on the <u>Quality Schools</u> <u>Package</u> page on the departmental website.

Use and disclosure of personal information

Your personal information is protected by law under the Privacy Act 1988 (Cth) (Privacy Act). Personal information is information or an opinion about an identifiable individual. Personal information includes an individual's name and contact details.

Any use or disclosure of your personal information must occur in accordance with Privacy Act and the Australian Education Act 2013 and Australian Education Regulation 2013.

Your personal information provided to the department through the Collection may be:

- disclosed to the ABS for the purposes of capacity to contribute calculations and analysis as a part of the Multi-Agency Data Integration Project (MADIP). Further information about MADIP can be found on the MADIP page on the ABS website.
- disclosed to a contracted auditor where the department may from time to time, carry out an audit of
 a school's submission to the Collection. The contracted auditor compares the school's submission with
 the student enrolment information held by the school and will not use the information for any other
 purpose.
- disclosed to its service providers for the purposes of the provision of information and communications technology support services to the department.
- used or disclosed where it is otherwise required or authorised by law.

The department does not intend to disclose your personal information to any overseas recipients.

The department's privacy policy can be found at www.dese.gov.au and includes information on:

- how individuals can access and seek correction of the personal information held by the department;
- how complaints about potential breaches or breaches of the Privacy Act can be made;
- how the department will deal with these complaints.

The department commissioned an independent privacy impact assessment (PIA). The PIA assesses the flows of information under the Collection, compliance with the Privacy Act and measures in place to safeguard the personal information being collected. You are not required to do anything. Your school is responsible for providing the requested details to the department; however, you may wish to ensure that your school has the most up-to-date and correct details for your family.
